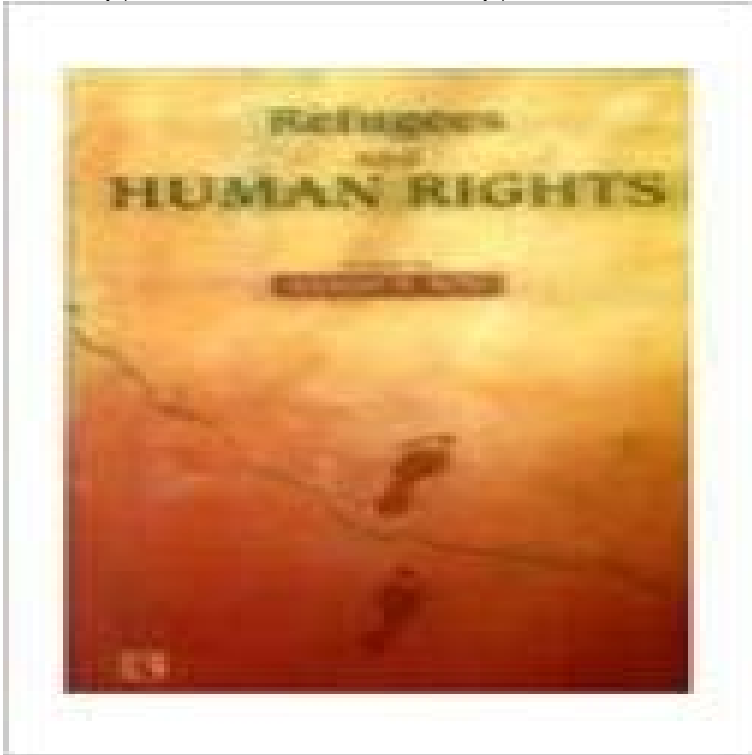


## Refugees and Human Rights
