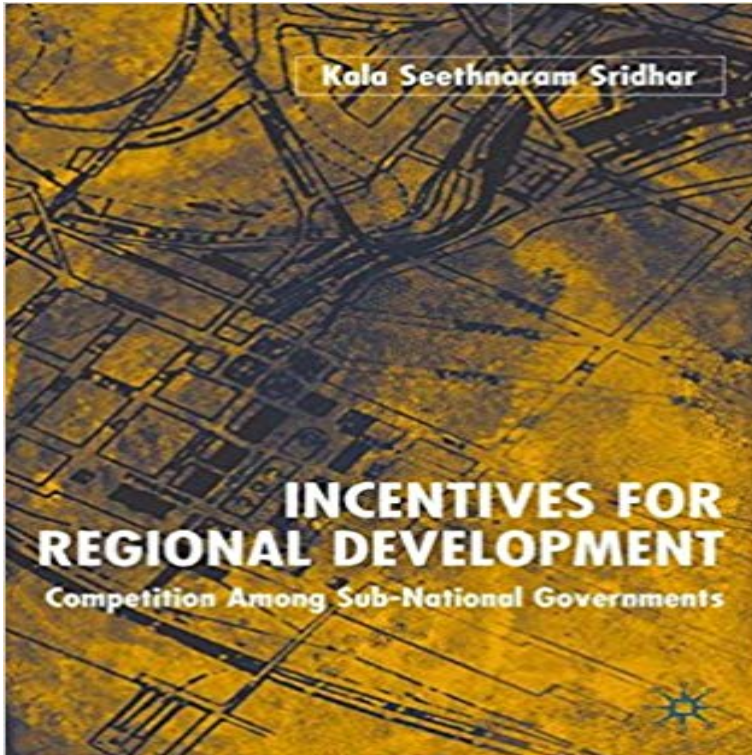


Incentives for Regional Development: Competition Among Sub-National Governments

Do tax and infrastructure incentives have any effect on the unemployment rate of areas adopting them?
