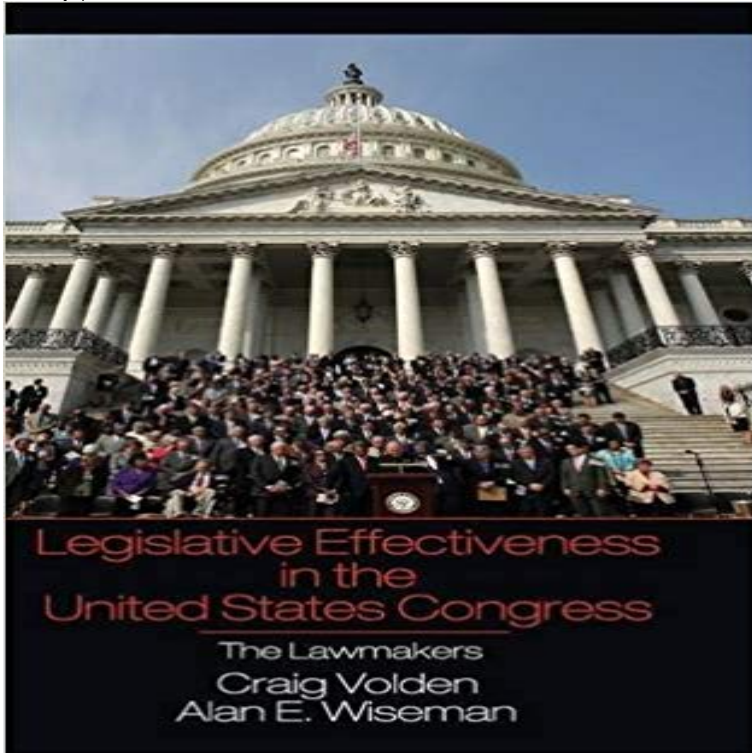


# Legislative Effectiveness in the United States Congress: The Lawmakers
