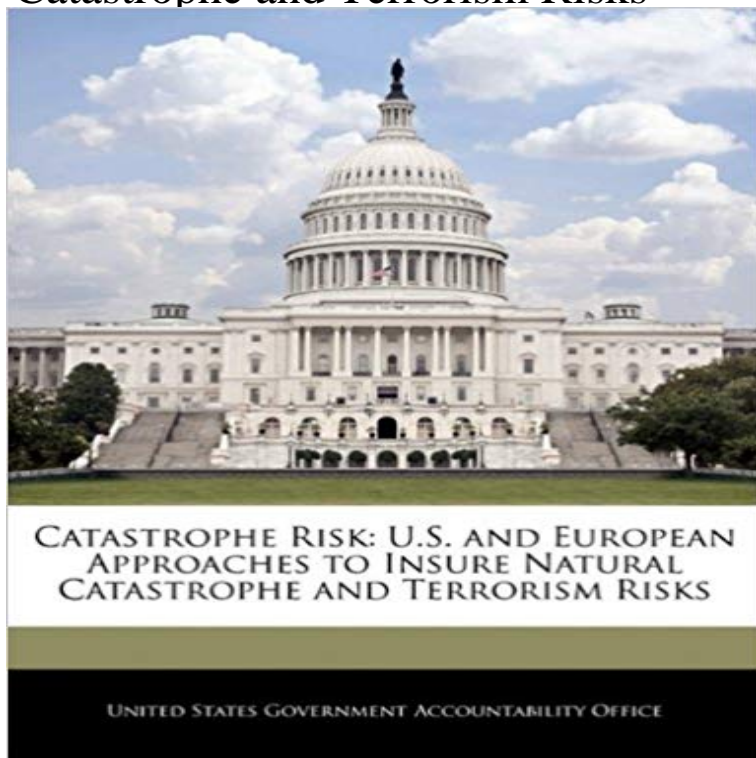


Catastrophe Risk: U.S. and European Approaches to Insure Natural Catastrophe and Terrorism Risks
